SECTION 4: FIRST AID MEASURES.

4.1 Description of first aid measures.

In case of doubt or when symptoms of feeling unwell persist, get medical attention. Never administer anything orally to persons who are unconscious.

Inhalation.

SECTION 5: FIREFIGHTING MEASURES.

Flammable product, the necessary prevention measures should be taken in order to avoid risks, In case of fire, the following measures are recommended:

5.1 Extinguishing media.

Suitable extinguishing media:

Extinguisher powder or CO₂. In case of more serious fires, also alcohol-resistant foam and water spray.

5.2 Special hazards arising from the mixture.

Special risks.

Fire can cause thick, black smoke. As a result of thermal decomposition, dangerous products can form: carbon monoxide, carbon dioxide. Exposure to combustion or decomposition products can be harmful to your health.

During a fire and depending on its magnitude the following may occur:

5.3 Advice for firefighters.

Use water to cool tanks, cisterns, or containers close to the heat source or fire. Take wind direction into account. 6.3 Methods and material for containment and cleaning up.

Pick up the spill with non-combustible absorbent materials (soil, sand, vermiculite, diatomite, etc.). Pour the product and the absorbent in an appropriate container. Pour the decontaminator on the remains in an opened container and let it act various days until no further reaction is produced.
